IN THE EVENT THAT THE PARTIES DESIRE TO CHANGE, ADD, OR OTHERWISE MODIFY ANY TERMS, DATES, LOCATIONS OR ITEMS LISTED ON THIS AGREEMENT, THEY SHALL DO SO IN WRITING AND AGREED UPON BY BOTH.

PAYMENT: PURCHASER IS GUARANTEED A 100% REFUND OF RETAINER OR BALANCE, IF PERFORMER CANCELS FOR ANY REASON WITHOUT SUITABLE REPLACEMENT. PURCHASER AGREES TO PAY THE TOTAL AMOUNT TO **JOSH VOLPE**. **ANY BALANCES MUST BE PAID IN FULL 30 DAYS BEFORE EVENT DATE.** No charge for setup/tear down. Additional fee of \$150/hour may occur outside of purchased time limit. **PLEASE MAKE ALL CHECKS OUT TO JOSH VOLPE.**

PHOTO BOOTH PROPS/EQUIPMENT: PROPS & EQUIPMENT ARE EXPENSIVE TO REPLACE. ALL PROPS AND EQUIPMENT ARE FILED AND CATALOGED. ANY DAMAGE OR THEFT WILL RESULT IN A \$20 PER PROP AND \$500 PER IPAD & CAMERA FEE TO THE PURCHASER OF THIS CONTRACT.
